### **Did You Know?**

Many of our homes are close to 50 years old and the main water line coming in from the street is also 50 years old. The line from the meter to your home is your responsibility. If it springs a leak, you may end up with expensive water and repair bills especially if the line goes under a driveway. To check if you have a leak turn off all the water in your home and look at the water meter. If the dial on the meter spins you probably have a leak. Time to call the plumber!



# **Speed Bumps Are Installed**

Thanks to the City of Kenmore for paying for the two speed bumps that have been installed on 58<sup>th</sup> Ave. NE near Aqua Club. Your UNA Board started working on this in January 2014. Years ago we asked Kenmore about speed bumps and encountered opposition. Through persistence we have prevailed!!

Hopefully, this will reduce the speed of cars in that area, however we are still concerned about traffic using our neighborhood as a bypass for 61<sup>st</sup> Ave. NE.

# Bothell Way (Hwy 522) Work Has Started

You have probably noticed that work on the next segment of Hwy 522 has begun. During the next year construction will involve the area from 68<sup>th</sup> NE to 61<sup>st</sup> NE. Sidewalks, landscaping, and turn lanes will be included.

Eventually our entrance on 60<sup>th</sup> NE will be impacted as a double left turn lane to 61<sup>st</sup> NE is in the plans. Drivers will be able to make a "U-turn" at the 61<sup>st</sup> NE intersection and come back west on HWY 522 to enter at 60<sup>th</sup> NE. This should decrease the number of cars using Uplake as a shortcut to avoid 61<sup>st</sup> NE. Also included in the work will be a widening of 61<sup>st</sup> NE near Jack in the Box and work on the south leg of 61<sup>st</sup> NE as it going down toward the lake.



### **Entrance Work**

The UNA board has accepted the resignation of **Diane Quinn** and **Jan Schultz** as the landscapers for our entrances. We thank them for all of their work over the years. After getting bids from three landscaping companies the board selected Collin's Landscaping. Collin Hards does work for several area residents and is the nephew of former long-time resident, Fran Owen.
